## PROFILE: GEOFFREY HESS '91

### BROTHERS COLLABORATE TO BUILD STADIUM

**G**eoff Hess '91 and Josh Getzler '90 met in high school but they didn't become friends until they became brothers. Josh recruited Geoff to join Alpha Chi Rho at Penn. Later they became partners on an effort to bring a new baseball stadium to New York City.

Josh and his father, Stanley, own and run the Staten Island Yankees in partnership with George Steinbrenner. Geoff Hess was

the senior adviser to then-Mayor Rudy Giuliani and spent a lot of time working out the business details of building the stadium with Josh.

"What makes it so nice is that the relationship [with Josh] was fostered and grew so tremendously in college that I ended up doing a very large transaction with him in New York City and, under Giuliani's leadership, built a \$40 million stadium," Brother Hess said. He calls the stadium "a

tremendous legacy for Giuliani."

"If you had said to me in college that I would someday build a \$40 million baseball stadium with Josh Getzler, my big brother, I would have said you were out of your mind."

In the fraternity, Brother Hess served as social director and pledge director. As senior adviser to "America's Mayor," Hess was responsible for designing new initiatives,

overseeing the reengineering of management throughout NYC government, and in a large part, reacting to the news of the day.

"I was with [Giuliani] on Sept. 11 — trapped in a building with him, and stood at the foot of the tower and watched people jumping," Brother Hess said. The mayor and those with him reacted with horror.

"We were trapped in the building at 75 Barclay Street," recalled Hess. "We ultimately got out through the help of a maintenance worker who took us underground and we came out in the lobby of a building a number of blocks away."

"What Rudy always said was that ultimately New Yorkers were resilient enough to get through it, and we would come out stronger than we were before."

As of January, Hess is a director in Giuliani Partners, a consulting and investment company started by the former mayor. However, he said, "You may find me in the White House in a few years."

The reporter asked: With Giuliani? Hess said: "Wouldn't that be great?"

Asked about the value of our fraternity, Brother Hess said, "the greatest benefit is not the great parties or all the football games, but rather the relationships you make. That, ultimately, is the most lasting value of the fraternity.

"It teaches you how to get along with people," he said. "You're really forced into a group that's diverse ... and I think Alpha Chi Rho at Penn is probably more diverse than any other group on campus. Here I am, a Manhattan kid who grew up in a prep school in New York City, and now

I'm thrown in with this diverse group. It really teaches you how to deal with people of many different backgrounds, with different beliefs and behaviors."

Hess has stayed in touch with several brothers.

"Mike Alfano '93 is a lawyer for a hedge fund in Bermuda and is doing very, very well," Hess said. "Ed Tuohy '91, a doctor at Yale, was my roommate freshman year in the dorms. He was a Pennsylvania football player ... goes on to rush with me, and ends up being the best man in my wedding. We were very different kinds of people. I was a preppy kid from Manhattan. He was from a small town in Pennsylvania. I was wearing a blazer, he was wearing a sweatshirt. I wouldn't have had the opportunity to develop the relationship I had with Ed but for Alpha Chi Rho."

Hess is also in contact with Jason Fortin '92 who works in New York City. He would love to hear from Flite Freiman, who didn't graduate from Penn, and Gil Vogel '90.

Geoff's career path started with a summer internship in Giuliani's office when Giuliani was the U.S. Attorney for the southern district of New York in the 1980s.

In the summer of 1989, Hess volunteered to work for Giuliani's first and ultimately failed mayoral campaign. In 1997, he was appointed special counsel to the deputy mayor for operations in the Giuliani administration.

"This is the classic example of not burning bridges," Hess said. "I stayed in touch and friendly with the people I worked with over those two summers, further developing those relationships."

After two years in city government, he went to work for a global real estate company, Tishman Speyer Properties. In October 2000, "Mayor Giuliani asked me to return to public service, and he appointed me senior adviser to the mayor."

Hess describes himself as "a tremendous sports fan and season ticket holder of the New York Yankees. He also attends minor league games like the Staten Island Yankees and the Brooklyn Cyclones, a Mets farm team. He learned to scuba dive in Hawaii and got certified.

"I have also become an avid fan of thoroughbred horse racing," Hess said, adding that this would not surprise brothers who know him. However, they will be amused to learn that Hess "managed the effort, still not finished, to privatize New York City Off-Track Betting (OTB), which is a billion dollar corporation owned by the city. The Giuliani administration turned it around from a company that was losing money in 1993 to a company that generates in excess of \$30 million per year. Everyone knew that I loved horse racing. It's funny that I wound up doing something with that business."

**PROFILE: DAVE MUDGE '73**  
**REMEMBERING A DIVERSE GROUP OF MEN**  
*United by Hatred of Chicken a la King*

**D**ave Mudge is currently an emeritus board member of the Phi Phi Club and was one of the chief architects of the alumni board's revitalization. This Q&A profile with Brother Mudge is part of an ongoing series to help us get to know our brothers better.

**Q: What are some of your favorite memories of the fraternity?**

- Playing touch football across the street at the "Gaza Strip," the open space between Hillel and the Christian Association.
- Playing hearts for untold hours at a time — with Howard Ellis '72, John Morris '72 and Bill Farran '72.
- Blackjack games that would go on for days.

**Q: Why did you join?**

After receiving an invite, I realized that the house was really diversified, unlike many of the other houses that had a distinct "flavor" in terms of members. AXP had Christians and Jews, blacks and whites, flower children and ROTC types, preppies and good ol' country boys, jocks and nerds. A few foreigners helped to complete the picture. It was impossible to type the house. As a learning experience, it was invaluable.

**Q: What was your nickname?**

None that I ever heard of, although I'm sure that I was called a few things.

**Q: Who were your Fraternity roommates?**

I was lucky enough to live in the house for three years. My sophomore year was in the second floor front (north) room, with Robert Kloss '72. My most memorable time with Bob was after his final exams

in the spring, when he had heard that he had been accepted to med school. It took days to clean up after his celebration. I doubt if he can remember any of it.

The next two years I roomed with Tom Gagan '73 — junior year in the same room as sophomore year, and senior year, when I served as president, across the hall in the second floor front (south). I did that just to change rooms. Tom was the best roommate I could have hoped for. I remember planning my run for the presidency of Phi Phi, as well as laying the groundwork for our first toga party. We also had to deal with the problem of the meal program coordinator exhausting the year's food budget before the first semester was over. I was nearly lynched for serving chicken a la king twice a week.

**Q: What kind of influence did the Fraternity have on you?**

There're about three-and-a-half years where I can't remember anything. Seriously, the experience of trying to pull together the incredibly disparate menagerie that was AXP in order to function not only as a house, but as a positive influence on both the university and the outside world helped to train me to deal with volunteer groups of different backgrounds and goals.

**Q: With whom do you stay in contact?**

I stay in contact with many of the brothers who come back for Homecoming. I occasionally touch base with my roommate of two years, Tom Gagan '73 (who recently celebrated the birth of his first child). I am always interested in reestablishing contact with

all of the brothers that I've worked with over the years, which by now number in the hundreds.

**Q: Tell us about your family.**

I married the former Pat Conaway, who used to teach ice skating at Penn. She still teaches skating at local rinks. We bought my parents' house, meaning that I've now kept the same address (Burlington, N.J.) for 50 years. We have one son, Sumner, who was born in 1984 and is now 17.

**Q: What other activities were you involved in during your time at Penn?**

Besides being the undergraduate president of the Phi Phi Chapter, I devoted four years to the Penn Band, also serving as president of that organization. I also participated in NROTC for four years, which provided my scholarship, kept me out of the draft, and provided me with immediate employment after graduation.

**Q: What do you do for a living?**

After spending five years in the Navy, I was able to pursue my true desire, and I've been working as an archaeologist. I've spent the last 21 years working for the State of New Jersey in that capacity.

**Q: What organizations are you involved with now?**

Besides serving on the AXP board of directors for the last 20-plus years; I am currently the at-large representative for the Middle Atlantic Archaeological Conference, in which capacity I've served for the last six years. I am the current president-elect for the Eastern States Archaeological Federation, and will be installed as president next year, barring any

scandals. I have served as an officer for the Archaeological Society of New Jersey. I serve as an ordained elder in my church (Presbyterian), which I have done for almost 15 years. I also serve as the mission chairperson for the Presbyterian Church for the entire South Jersey region. I have been serving on the Florence Township Environmental Commission for almost 15 years.

**Q: What hobbies do you enjoy?**

I do a little antiquing, surf the 'net, read history. I am attempting to write my doctoral dissertation, and I travel out west once a year.

**Q: What goals do you have for the next few years?**

I still have some plans to improve the various organizations that I work with. For better or worse, the graduate board of AXP is a lot stronger now than when I was an undergraduate. We've renovated nearly every part of the house, including adding a new roof, repointing of the brickwork, and finally, installing new windows. Along the way we've rebuilt the upstairs bathrooms, replaced the boiler, installed new electrical service and Internet connections, and survived being disbanded for a semester. With all that, we still have a positive cash flow and money in the bank. We've come a long way since the time when I called a meeting of the board of directors and I was the only one who showed up (and no, that was not how I got elected president).

Even so, we need to continue to foster better undergrad involvement, higher levels of participation from the grads, and work toward an endowment fund.

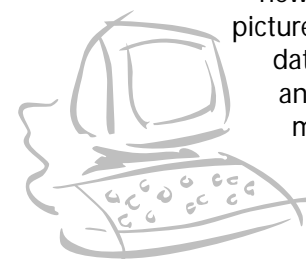
